

HOW MANY PRESIDENTS?

The office of "President" is constructed with multiple offices which are all assumed to be exercised or potentially exercised by one man (wearing multiple hats).

Multiple hats example: Lincoln was a Bar Attorney and Esquire (joined the Illinois Bar in 1835) and the Titles of Nobility Amendment (ratified and added to The Constitution for the united States of America in 1819) prohibits Bar Attorneys from serving in land jurisdiction government, so how did Lincoln get elected and serve as President in 1860?

The short answer is that Lincoln was never President under the land jurisdiction and held no office in any land jurisdiction government.

This is one of the Big Beefs that led to the Secession of the Southern States.

Lincoln wasn't eligible to serve as President of the Federal Republic, but he was eligible to serve as President of the Territorial United States in the sea jurisdiction, and also as President of the Municipal United States in the air jurisdiction.

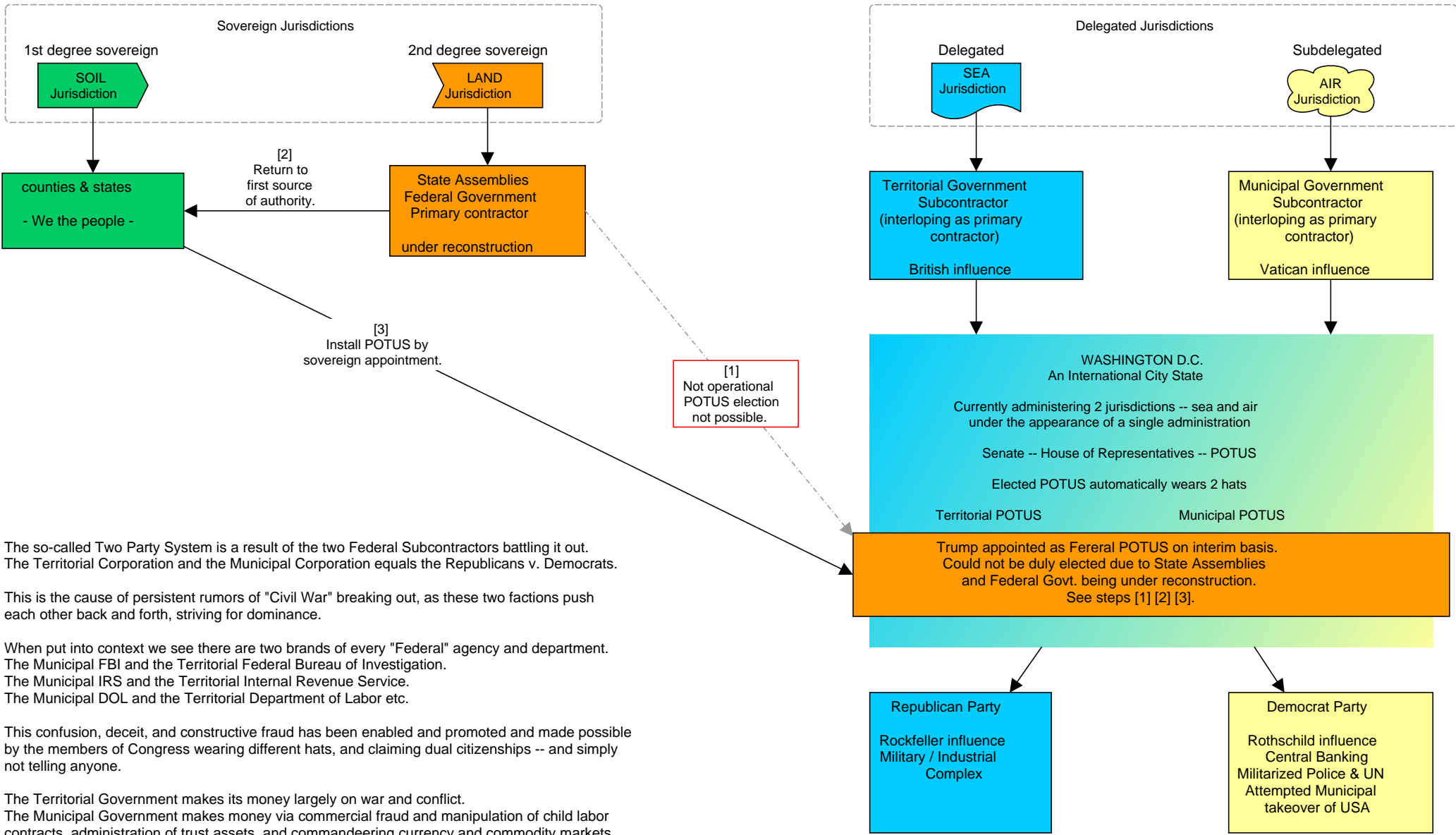
So he simply didn't enter the land jurisdiction office --- didn't wear that "hat" --- and represented only the two foreign Federal Subcontractors, instead.

If you look at the records, you will see that Lincoln consistently signed all his paperwork in one of three offices:

1. President of the United States of America (Territorial Government of the sea jurisdiction)
2. President of the United States (Municipal Government of the air jurisdiction)
3. Commander-in-Chief (Territorial Government of the sea jurisdiction)

There is no record of him ever acting as The President of **The United States of America** (Federation of States of the land jurisdiction), nor as the President of **the States of America** (Confederation of States of the land jurisdiction), nor as the President of the united **States of America** (the Federal Republic of the land jurisdiction).

The so-called Two Party System is a result of the two Federal Subcontractors battling it out. The Territorial Corporation and the Municipal Corporation equals the Republicans v. Democrats.

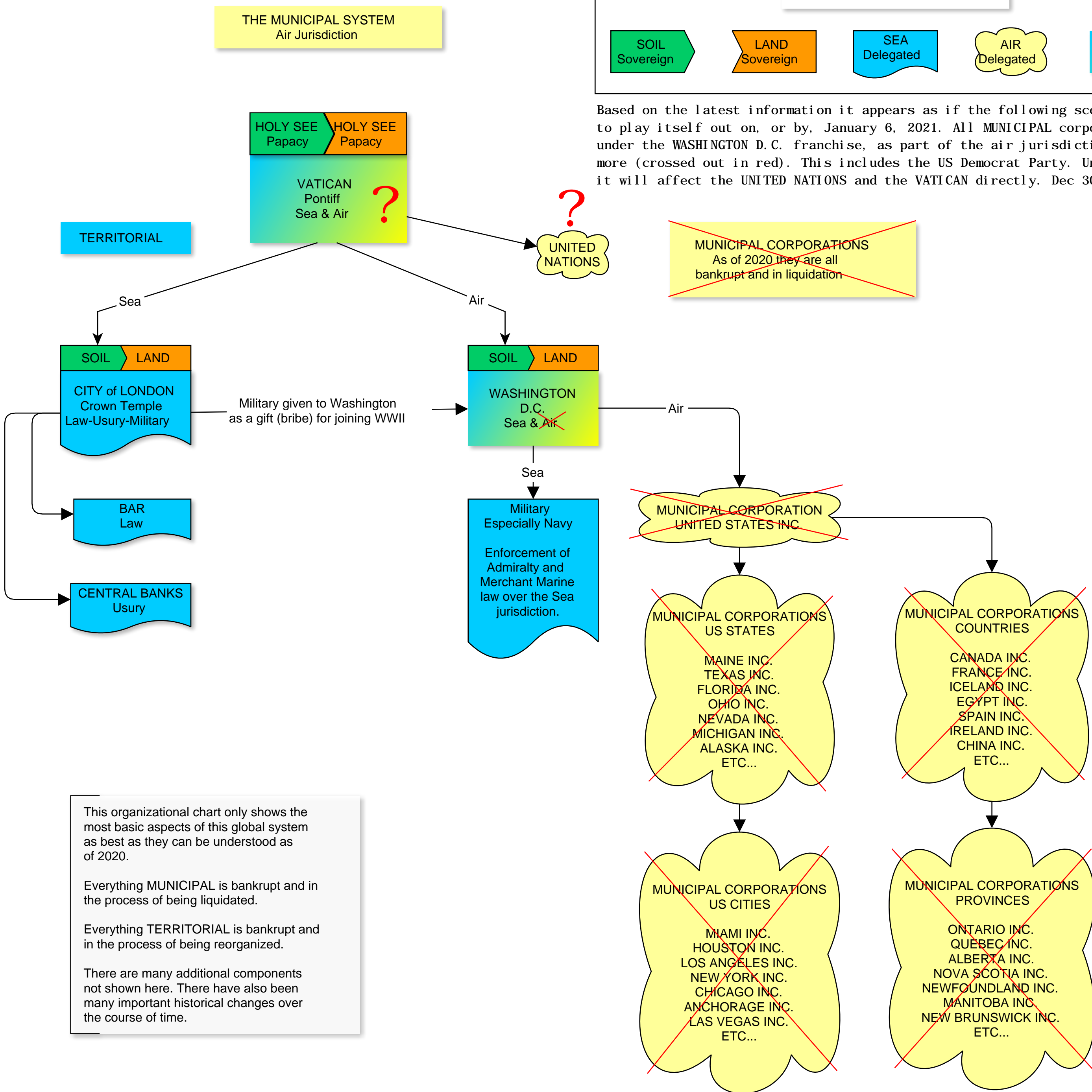
